

The 26th IFSCC Congress is on its way...

The City of Buenos Aires is expecting you between September 19th and 23rd, 2010, to take part of a new edition of the most important scientific and technical meeting of the International Cosmetic World. The Organizing Committee and the Argentine Association of Cosmetic Chemists (AAQC) as a whole, are working hard to achieve a careful reception and attention of every participant.

SCIENTIFIC PROGRAM INNOVATION & RESPONSIBILITY: COSMETICS FOREVER

Since when the Organization Committee of the 26th IFSCC Congress begun its work, we asked ourselves which were the keys of sustainable development for our activity and our industry. We agreed on the idea that two fundamental pillars were needed:

Innovation: the constant search for in depth knowledge and more effective ways to act on the biochemical routes of the skin, new active and protective molecules, new screening tests, new ideas and materials for better and safer products have become an indivisible part of our art. Responsibility: to survive in the long-term, our industry has also to be clean with our habitat, trustworthy for our customers and sincere, with scientifically proofed marketing claims.

Thus, in this meeting, which will concentrate for a few days in one place whatever is new in our R&D areas, we expect to hear the best proposals that emerged from them during the last two years, as well as the advances done for the responsible care of mankind and its environment. In this context, the 26th IFSCC Congress is calling for papers in the following categories:

» Cosmetics: physical, chemical and biological aspects

This topic covers the search of new materials and formulations, in particular where the delivery is controlled by specially-designed means, or new active molecules are found. They must be safe and with proven efficacy. This point also covers the necessary technology to handle this kind of materials, and control the results of the processes done upon them.

» Well-being and beauty cosmetics

In this chapter we want to explore in depth the relations between well-being, sensorial response, immune system and neurotransmitters. Also the psychological aspects between self-conscious image, physical and spiritual equilibrium.

» Protective strategies

We are submitted constantly to the environmental aggressions, mainly through sun radiation, but also by pollution, stress and other external negative stimuli.

Cosmetics can do a lot to preserve our body from some of their deleterious actions: whatever is new in Sun-protection, hair-care, body and hand-care and anti-aging treatments should go into this section.

» Society and cosmetics

The scientific works presented under this title should accomplish our last objective: new ideas and materials for environmental-friendly cosmetics. Assessment of inocuity, new methods to replace animal testing, changes produced, as a consequence, in the international legislation.

CALL FOR ABSTRACTS

DEADLINE FOR ABSTRACT SUBMISSION: November 16nd, 2009

Abstracts received after this deadline will not be considered. All abstracts must be submitted through the Congress web site: www.ifscc2010.com

A. RULES FOR THE SUBMISSION OF ABSTRACT

Abstracts are peer reviewed and ranked by experts in the selected topic and they are allocated to PODIUM or POSTER Sessions. Authors who do not wish to be considered for oral presentation must check the box "poster" on the abstract form. However, please note that the Scientific Committee of the Congress will take the final decision on your mode of presentation. All submitted abstracts will be sent to an International Panel of Reviewers. Reviewers' decision is final and can not be appealed. Original scientific material is welcome and should not have been published or presented at other international meetings on a prior occasion. Submission of an abstract indicates acceptance of and compliance with the abstract submission rules, the scientific validity of the presentation, and that all their authors have read and approved the abstract and its contents before submission to the Secretariat. By submitting an abstract, the authors confirm that the work was conducted in accordance with current ethical standards and regulations in biomedical research. Failure to adhere to these standards will result in rejection of the abstract.

All accepted abstracts will be published and will be available on a book or CD-ROM, and distributed to all registered participants.

Accepted abstracts are official communications to the Congress. The presenting author agrees to register, attend the Congress and present the abstract as scheduled.

The presenting author MUST BE REGISTERED at the time of acceptance of the abstract which will be communicated by March 16th, 2010. Abstracts accepted with no registered participant by May 16th, 2010 will not be published.

B. INSTRUCTIONS FOR PREPARING ABSTRACTS

- **b.1.** Abstracts must be written and presented in English.
- **b.2.** Abstracts should be structured as follows:
- **Title:** Use a concise title that indicates the content of the abstract. The complete title should be capitalized and not exceed 250 characters. Refrain from using abbreviations in the title.
- Authors: Surname and names for every author must be provided. Do not include

degrees or titles. The presenting author should appear in first place, underlined. Author's names appearing on more than one abstract must be identical.

- Affiliations: Each author should be listed with one or more institutions. Include in each institution city, state/province, and then select the corresponding country from the matchcode. Do not include department, division, laboratory, etc.
- **Text:** It should not exceed 5000 characters including spaces. Abstracts will be reproduced exactly as submitted and will not be edited in any way. Do not include in the text references that may lead to the identification of the authors/affiliations.
- **b.3.** It is mandatory to indicate your preference for PODIUM or POSTER Sessions. The Scientific Committee reserves the right to change the type of presentation.
- **b.4.** Up to four keywords which summarize the contents of the abstract can be entered and will be used for indexing the Abstract Book. Abstracts not conforming to the required format will be disqualified.
- **b.5.** For detailed required structure of the abstract please refer to the section Abstract/ Rules of the Congress website.

C. TOPICS

For reviewing and scheduling purposes, abstracts will be divided into thematic areas. Please indicate in the box the appropriate topic classification to which your abstract belongs. The Scientific Committee will attempt to respect the authors' option regarding their self-assignment to a special topic, but it reserves the right to change the allocation in order to achieve a well-balanced scientific program.

D. PUBLICATION

Fach author who submits an abstract through this website, states that he is entitled to submit it, that the coauthors agree with its content, and that the work complies with ethical and legal requirements and does not infringe legal rights of third parties. Furthermore authors whose paper is accepted for presenting at the Congress agree through this way that they forfeit any copyright of the abstract and the paper in benefit of the AAQC for publication. As well the authors agree also that the paper is original and has not been published elsewhere and will not be published until after the Congress. If, however, the paper submitted has been published before presenting at the Congress, information regarding where and when the paper was published must be provided.

E. RECEPTION OF FULL PAPERS

The due date to receive the complete papers will also be extended two weeks. The new date has been fixed on May 16th, 2010. Full papers should be sent through the website. We comply to inform the authors that, due to organizational lead-times, no further extension will be possible.
