4. Progress update (ASCS)

- ASCS 2023 India
 - Date change was proposed by the Indian Society due to a short interval after IFSCC 2023 Barcelona. The new schedule for March 2024 was accepted unanimously.
 - It will be a good opportunity to raise the awareness of the Indian Society. A good marketing plan should be important.
- ASCS 2025 Philippine
 - No major concerns regarding ACSC 2025 in Philippine.

5. Progress update (IFSCC 2026 (Australia))

- Venue: Australia Adelaide Convention Centre(10minutes by car from the airport)
- Date: 29th September - 1st Oct
- To be held in consideration of sustainability
- Expecting 800 participants(assuming the Chinese lockdown is over)

6. Future venues for IFSCC Congresses

- The 2029 Congress is scheduled to be hosted by the Society in ZONE 1 and should be decided in 2022 (7 years before the Congress). However, no society in ZONE 1 is currently interested in hosting the Congress, and ZONE 1 requested to extend the deadline by the next ZONE 1 meeting at Incosmetics spring 2023. The IFSCC Praesidium accepted the proposal and determined that the 2029 Congress will be hosted by the society in ZONE 2 if ZONE 1 gives up the opportunity.
- The Japanese Society would like to take the opportunity to host the 2029 Congress since the last 2020 Yokohama Congress was held virtually due to the Covid pandemic. Other ZONE 2 Societies understood that the willingness of Japanese Society is reasonable.
- Since changing the host country of the 2029 Congress is an exceptional measure

due to the difficulty of hosting in ZONE 1, all ZONE 2 members agreed that ZONE 2 should host the Congress in 2030 as scheduled.

7. Any other business

-Schedule dates and create an official homepage to allow people to make presentation plans.
- Middle East society status
-Dr. Yamamoto will contact Mr. Mohammed to check on the current participating countries and activities.
